



# AGENT RELEASE

If someone other than the registered bidder will be removing purchases, you must:

- i) complete this form to designate an AUTHORIZED AGENT,
- ii) send a photocopy or picture of your driver's license matching your name as registered,
- iii) if you are using a 3<sup>rd</sup> party shipping company, they must provide a bill of lading and Certificate of Insurance (in accordance with requirements posted specific for the sale).

- Items subject to this release were purchased by me per the previously agreed to terms of sale, which included but were not limited to the following: all items are sold 'As-Is, Where-Is' and "With All Faults"; all sales are final; and there will be no refunds, returns or exchanges.
- Once items are picked up, I shall release ThreeSixty from any and all claims related to my purchases. While items are purchased 'As-Is' and claims may be rejected based on this term of sale, I understand that any claim I may have regarding my purchase must be made prior to my Agent picking up the item(s) for such claim to be considered.
- If items are being shipped by a 3<sup>rd</sup> party shipping company:
  - I understand that the shipping address must be provided on a Bill of Lading which matches the address on record for my credit card;
  - I understand that it is my sole responsibility to arrange for proper insurance coverage thru my shipper or waive such insurance at my own risk.
- It is my responsibility to ensure my agent brings proper ID matching the information provide on this form, and is familiar with the items to be removed. I release ThreeSixty from any and all responsibility for Agent's failure to properly or completely remove items. I also acknowledge that I may be responsible for the cost to dispose or resale any items left behind or abandoned by Agent.
